Dear Mr. Ibrahim,

Access Now is a global organization fighting to defend and extend human rights in the digital age, particularly for users most at risk. We are writing to draw your attention to your company's performance in the [2019 Ranking Digital Rights \(RDR\) Corporate Accountability Index](#). As you may be aware, the RDR Index evaluated 24 of the world's leading internet, mobile, and telecommunications companies, including yours, and found that all companies could make significant improvements in disclosing policies and commitments that affect their users' rights to freedom of expression and privacy.

Transparency on these issues not only supports human rights, but also helps ensure user trust. Investors also depend on disclosures to verify that companies are upholding their duty to respect human rights. Therefore, we invite you to offer a public response to the 2019 RDR Index results.

Axiata ranked 10th out of the 12 telecommunications companies evaluated, and saw no change in its RDR Index score from 2018. The company's score was based on an evaluation of its disclosed policies for its pre- and post-paid mobile services for its Malaysian company, Celcom. Axiata made some modest improvements, including strengthening disclosure of governance and oversight over privacy issues and improving its disclosure across a number of policies affecting users' privacy. We also commend Axiata for responding to our previous letter and making its perspectives public, and reaching out for consultations with Access Now.


However, there is still much room for improvement. We encourage you and the relevant officers within your company to read through the full RDR Index findings and recommendations, and the "report card" for your company in particular, and develop a public response to the issues raised here. But we have narrowed our recommendation to one timely, and achievable, objective based on our insights into the most acute issues facing at-risk users.
